2025 Common School Fund Distributions to Districts

In 2025, Oregon's Common School Fund will send \$76.8 million to the state's K-12 public school districts.

The total amount distributed is 3.5 percent of the Common School Fund, valued at \$2.38 billion as of February 2025. The Department of State Lands sends the total distribution to the Oregon Department of Education, which calculates the individual district distributions based on student population in each county and district. The calculation methodology is defined in ORS 327.410.

Funds are provided to districts in two equal payments. The first payment was sent to districts in February 2025; the second payment will be sent in July 2025.

The table below shows the amount each of Oregon's 197 public school districts will receive in 2025. The average 2025 distribution is \$389,607.

About Oregon's Common School Fund and School Lands

The Common School Fund has supported Oregon schools since statehood, when the federal government granted our new state nearly 3.4 million acres "for the use of schools." The State Land Board – Oregon's Governor, Treasurer, and Secretary of State – was established to oversee these school lands, which generate revenue for the Common School Fund.

The Common School Fund has two distinct components – the constitutional Common School Fund and the statutory Common School Fund. The constitutional Common School Fund is required by Oregon's Admission Act to be used for schools and by Oregon's Constitution to be managed for the "best interests of the people of the state." The statutory Common School Fund is subject to the direction of the Oregon Legislature as enacted in state statutes. For example, the revenue generated by school lands granted at statehood is constitutional. Revenue directed by state statute to the Common School Fund, such as the interest earned by unclaimed property, is statutory.

Today, approximately 681,000 acres of school lands in all 36 Oregon counties are managed by the Department of State Lands on behalf of the State Land Board. Ranchers and farmers, local governments, Tribes, businesses, and more work with the Department to lease and buy lands, plan for future community needs, and keep lands healthy. Most of those school lands are dedicated to generating revenue for the constitutional Fund, with a small percentage – about 25,000 acres – associated with the statutory Fund.
